(2) 企业开展研发活动中实际发生的研发费用, 未形成无形资产计入当期损益的, 在按照规定据实扣除的基础上, 按照实际发生额的 75% 在税前加计扣除; 形成无形资产的, 按照无形资产成本的 175% 在税前摊销。

(3) 企业为开展研发活动直接发生的研发人员工资薪金、对研发人员给予的奖励、研发活动发生的差旅费、交通费、专业咨询费、研发设施折旧费、研发设备购置费、无形资产摊销费、研发费用管理费等, 按照实际发生额在税前据实扣除。

企业委托外部机构或个人进行研发活动所发生的费用, 按照费用实际发生额的 80% 计入委托方研发费用并按规定进行税前扣除; 具备条件的企业受托进行研发活动取得的费用, 按照费用实际发生额的 80% 计入受托方研发费用并按规定进行税前扣除。企业委托个人进行研发活动所发生的费用, 不得在税前扣除。

企业委托境外机构或个人进行研发活动所发生的费用, 不得在税前扣除。企业委托境外机构或个人进行研发活动所发生的费用, 按照费用实际发生额的 80% 计入委托方研发费用并按规定进行税前扣除; 具备条件的企业受托进行研发活动取得的费用, 按照费用实际发生额的 80% 计入受托方研发费用并按规定进行税前扣除。

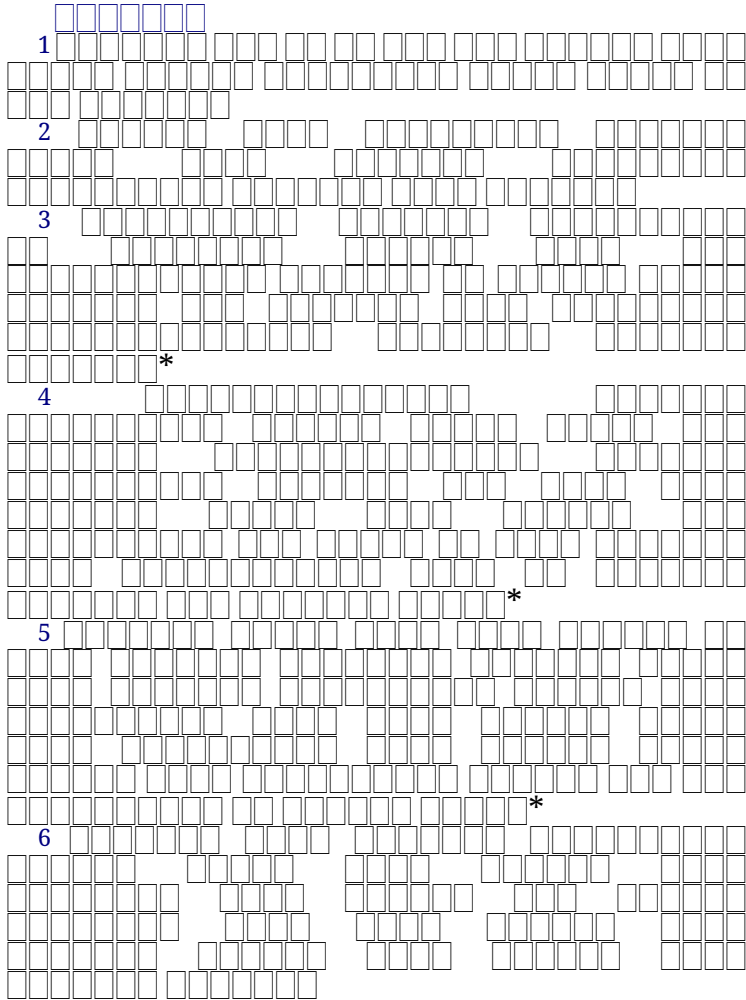
